1 Deviation from Budget

2 Dear General Members' Assembly,

The XVIth board would like to inform you about the financial situation regarding the Active Members Weekend (AMW) that takes place
from April 5th to April 7th, 2024.

5 This year, there was considerably more interest in the AMW than the XVIth board had anticipated. The voted-in budget for the AMW was based on an attendance of 70 active members, while the number of attendees has risen to 100 at the time of writing. The XVIth board considers the involvement of the active members to be positive and rewarding. The XVIth board believes it is important that all active members who want to participate, are given the opportunity to do so. Therefore, the board had to significantly increase their budget for the AMW, exceeding the limit of €400 that can be spent outside the budget without the General Members' Assembly's approval.

- 11 Adhering to the initial budget would have meant that the subsidy per participant would have decreased substantially. This would have
- 12 left less room in the budget to offer appropriate food and drinks and to organize fun activities, which would hinder the quality and
- 13 purpose of the whole weekend. The XVIth board has thus decided to use additional subsidies to organize the AMW. As this weekend is
- 14 an important moment to show appreciation for active members and the contributions they make to the association. With a limited
- 15 budget, this goal could not be adequately realized.

16 The board realizes that this deviation from the budget should have been approved during a General Members' Assembly (GMA) and

- 17 apologises for withholding the GMA from a vote on this matter. However, the decision to increase the budget of the committee without
- 18 organizing a GMA was made, as it was not possible to facilitate one within the timeframe of the ticket sale and the start of the activity.
- 19 The following table shows the SocialCie's committee budget as was voted-in at the Budget GMA on the 3rd of October 2023:

25 Nevertheless, the XVIth board offers their apologies for deviating from the budget without requesting prior approval from the GMA.
