## 1 Deviation from Budget

2 Dear General Members' Assembly,

3 During the investigation regarding the previous book provider StudyStore, legal advice was sought.

- 4 During a meeting with a lawyer, concerns about VAT payments in the invoices from the new book
- 5 provider WO4You were addressed as the XVI<sup>th</sup> board wants to prevent any tax-related issues in the
- 6 future. WO4You itself was also informed about the VAT payments and whether it was a possibility to not
- 7 include these in the invoices. They responded that they always added VAT to invoices and would
- 8 continue to do so. An in-person evaluation meeting with WO4You was held during which this matter was
- 9 further addressed and some more clarity was wanted. The verdict from this talk was to deviate from the
- 10 budget for now, as is described in detail below. The contact person from the company agreed that this is
- a possible way to deal with the taxes that are being paid out to us. WO4You further plans to discuss the
- 12 possibilities of removing VAT from their invoices to us with their financial team and will inform the XVI<sup>th</sup>
- 13 board of these options soon. For now, the first provision for the book sale will be paid
- 14 out containing VAT and the deviation from the budget will still be proposed, as can be found below.
- 15 To clarify the situation, the XVI<sup>th</sup> board had asked for legal advice. The lawyer stated that it is not the
- 16 board's responsibility if WO4You decides to pay the provision with VAT and that he recommended to
- 17 accept the invoices this way. However, he also explained that WO4You can request back the VAT
- 18 payments in the next 5 years due to the statute of limitations (verjaring). Therefore, the XVI<sup>th</sup> board was
- 19 recommended to make reservations in case this will happen.
- 20 The reservation would consist of the VAT amount that is paid out per invoice. This amount will not be
- 21 seen as benefit but instead as a reservation. After five years, the reservation will turn into benefit, when
- 22 WO4You does not request the VAT payments to be paid back within 5 years. The reservation of the VAT
- 23 money from this academic year would thus continue until the year of the XXI<sup>st</sup> board of SPiN in 2029.
- 24 This way of making it a reservation should be continued during every board year that involves a
- collaboration with WO4You.
- 26 The XVI<sup>th</sup> board thus requests a deviation from the budget, concerning the creation of the budget item
- 27 "Reservation VAT bonus study books". The current budget shows the following regarding the item
- 28 "bonus study books":
